Individual photographers are welcome to take informal photographs of plants, individuals, or subjects at Milburn Orchards for their personal use and enjoyment. If you are not selling your images or being paid to capture the images, you are encouraged to take and share as many pictures as you like.

By tagging us in pictures and using our location on any and all social media platforms, you are granting our Marketing and Publicity Coordinator access to use your photos on our social media platforms, emails, Farm Market slideshow, and all other advertising campaigns. ### Commercial photography guidelines

Photographers must obtain a permit if they wish to use Milburn Orchards’ setting as the background for formal and/or commercial photography/videography—see below permit fee/terms. This category includes family portraits, or similar. Please note that no ceremonies are allowed at Milburns under any circumstances. Mini sessions are not permitted. The following photographers are required to obtain a permit from Milburns:

- All who wish to use the area as a backdrop/setting for portrait and commercial photography.
- All portrait photography including, but not limited to: senior, engagement, family, graduation, wedding, etc.
- All commercial photography including, but not limited to: catalog, fashion, advertisement, promotion, etc.
- All photographs for any commercial use, even if the photographer is NOT a professional.

### How to Schedule a Photo Session at Milburn Orchards:

1. Schedule your session.
  - a. Choose a desired date and time. Photography sessions are only permitted during normal hours of operation and there are different admission fees for different days of the week depending on the time of year. This information can be found on our website, **www.milburnorchards.com**.
  - b. We do not accept calls to schedule appointments. Email **olivia@milburnorchards.com** with the completed and signed Photography Permit Application at least one week before the planned date, and we will email you to discuss the event details, admission fees, etc.
  - c. Photography sessions are not permitted on holidays or dates and times we are closed.
2. In lieu of a fee to use our facilities as your photography session, Milburns requires 7 digital photos and the release to use the photographs in advertising and marketing efforts, due within 10 days of your session. In addition, the permittee and client agree to tag Milburn Orchards in all images posted on social media.
3. On the date of your event, photographers and clients must check in at the Farm Market.
4. Contact Milburn Orchards immediately if you are unable to keep an approved Session Appointment.

### Agreement:

1. NO PETS on the farm premises for any and all photo sessions. Service animals are always welcome.
2. Each person entering the BIG BackYard for the photo session must pay the applicable admission fee.
3. No areas of the BIG BackYard may be closed or blocked off from other guests. Please be respectful and aware of other people.
4. Leave the area in the same condition and cleanliness as when you arrived.
5. We allow a camera and camera bag only. No lighting, ladders, props, etc.

6. Stay off all farm equipment including but not limited to tractors, etc. Everyone must obey the rules posted on signage around the BIG BackYard and all other areas of the farm.
7. We expect all visitors to be respectful of our farm, our employees, our animals, and our fields at all times.
8. Milburn Orchards reserves the right to ask you to move or leave the premises if you are disruptive or not complying with the farm's policies.
